**(TEMPORARY CLOSURE)**  
**ORDER NO. 2 2023**

**NOTICE** is hereby given that Neath Port Talbot County Borough Council intend is not less than seven days from the date of this Notice to make an Order under Section 14(1) of Road Traffic Regulation Act 1984 (as amended).

The effect of the Order will be to temporarily prohibit pedestrians, equestrians and cyclist from proceeding along the lengths of highways set out in the Schedule below whilst the Order is in force. During such periods as are indicated by traffic signs informing the public that the length of highways are closed.

The Order is necessary to enable the site development works to be carried out on The Wildfox Development Site adjacent to the Highways.

The Order will come into force on 3<sup>rd</sup> August 2023 and shall continue in force for a period of six months.

**SCHEDULE**

**Footpath 66 Cymmer**

That length of Footpath 66 Cymmer commencing at point C (Grid Ref. 28592 19579) and proceeding in a generally southerly, south westerly and southerly direction to point E (Grid Ref. 28590 19519) a total distance of 615 metres or thereabouts.

**Bridleway 42 Cymmer**

That length of Bridleway 42 Cymmer commencing at point A (Grid Ref. 28575 19590) and proceeding in a generally easterly direction to point B (Grid Ref. 28602 19591) then in a generally south south westerly direction to point C (Grid Ref.28592 19579) then in a generally south westerly direction to point D (Grid Ref.28524 19534) a total distance of 1255 metres or thereabouts.

### **Bridleway 43 Cymmer**

That length of Bridleway 43 Cymmer commencing at point F (Grid Ref.28483 19615) and proceeding in a generally south easterly, westerly and south south easterly direction to point G (Grid Ref. 2849119602) a total distance of 215 metres or thereabouts.

That length of Bridleway 43 Cymmer commencing at point I (Grid Ref. 28550 19602) and proceeding in a generally north north westerly and westerly direction to point H (Grid Ref. 28517 19609) then in a generally westerly and south westerly direction to point G (Grid Ref. 2849119602) then in a generally southerly direction to point J (Grid Ref. 2848119548) then in a generally south westerly, southerly, south easterly and southerly direction to point K (Grid Ref. 2849119504) a total distance of 1730 metres or thereabouts.

### **Bridleway 44 Cymmer**

That length of Bridleway 44 Cymmer commencing at point H (Grid Ref. 28517 19609) and proceeding in a generally southerly, south westerly, south easterly and south westerly direction to point J (Grid Ref. 28481 19548) a total distance of 770 metres or thereabouts.

### **Alternative Routes**

The public are advised to use the existing public rights of way and highway network.
